This encompasses the paying of school/University fees, boarding (including bedding, trunks for storage, swimwear, travel bags, stationary, school books, bags and uniforms) and other necessities. The intention is for these kids to be able to become business men and women, thus contributing to the building up of the country and the betterment of South Africa's next generation.

4b (Code: ) (Expenses \$ 101,889. including grants of \$ 91,205.) (Revenue \$ ) DTCare is delivering aid and providing funding for relief services to individuals and businesses in and around Beirut. DTCare is also providing humanitarian aid (diapers, formula, school supplies, etc) to individuals and local organizations affected by the current economic strain.
